*As of August 2022, MMA has been approved for the Child Care Fee Reduction Initiative (CCFRI) for the Preschool/Kindergarten programmes. Fees above will differ based on number of days that school is in session each month. CCFRI funding is up to a maximum of \$545/month for full-day students, \$272.50/month for half-day students (subject to change as per government guidelines).

Funding is applied September to June only. Due to the nature of the CCFRI funding, all fees are to be paid monthly.

Upon student's placement, one month's tuition, applied to June of the next scholastic year is payable and non-refundable.

Tuition discounts apply only to the tuition portion of the monthly payments for siblings:

**20% for the second child and 30% for subsequent children concurrently attending MMA.
